GOOD SPORTSMANSHIP CONTRACT

The La Jolla Figure Skating Club and its members are governed by the USFSA Code of Conduct (GR1.02, page 282 USFSA rulebook). That code has been expanded upon to include: At any LJFSC event or activity, or in area adjacent to any such event or activity, there will be:

- *NO SMOKING *NO OBSCENE LANGUAGE *NO DRINKING**
***NO APPAREL WITH OBSCENE LANGUAGE OR PICTURES**
***NO ACTS OF VIOLENCE *NO POSSESSION OF ILLEGAL DRUGS**
***NO POSSESSION OF WEAPONS**

We are all representatives of our Club and rink, on the premises of Ice Town, in the Mall, as well as at away events. Our conduct directly reflects back upon the Club, its members and family members. We expect all of our members to treat each other, and those we have contact with, with respect.

The board of the La Jolla Figure Skating Club has approved the following policy in response to unsportsmanlike conduct.

- First Reported Offense: Verbal warning to the skater.
- Second Reported Offense: Written warning to the skater, parent and coach.
- Third Reported Offense: Suspension of Club privileges for 1 week.
- Fourth Reported Offense: Suspension of Club privileges for 1 month.
- Fifth Reported Offense: Skater will be expelled from the Club.

All efforts will be made to verify all reported offenses. Anyone making false accusations is subject to penalty. Disputes will be turned over to a USFSA arbitrator. Criminal offenses may result in expulsion on the first offense and will be reported to local authorities.

This contract is designed to make our Club and rink a safe environment to pursue the sport of figure skating, and to provide an appropriate learning environment which is pleasant to all involved.

SPORTSMANSHIP: Honorable or sportsmanlike conduct.

SPORTSMAN: One who abides by a code of fair play in games or in daily practice.

USFSA GR 1.02 CODE OF CONDUCT

The following code of conduct applies to all participants in activities hosted, supported, sponsored, or engaged in by the USFSA, including but not limited to competitions, exhibitions, and training camps:

I recognize that my participation in all activities hosted, supported, sponsored, or engaged in by the USFSA, including but not limited to competitions, exhibitions, and training camps is an honor and privilege that carries certain responsibilities. I agree to fully abide by the rules and guidelines set forth by the USFSA or its properly designated agents. As a precondition to participation in activities hosted, supported, sponsored, or engaged in by the USFSA, I will adhere to the following tenets in good faith:

A. I will exhibit the highest standards of fairness, ethical behavior, and genuine good sportsmanship in all of my relations with others.

B. I will not damage public or private property. I understand that I may be held financially responsible for damage deemed to be wantonly or willfully executed on my part, and that I may be subject to disciplinary action by the USFSA.

C. I will not use or possess illegal drugs and I will not engage in criminal activity. I understand that, if I am found to use or possess illegal drugs, or if I am found to engage in any criminal activity during any activity hosted, supported, sponsored, or engaged in by the USFSA, I may be subject to criminal penalties as well as penalties imposed by the USFSA.

D. I will adhere to the rules of the USFSA and the host organization at all activities hosted, supported, sponsored, or engaged in by the USFSA.

E. I will conduct myself in a manner not detrimental to the welfare of figure skating. I understand that my actions reflect on the USFSA and the sport of figure skating both positively and negatively. I understand that if my acts, statements, or conduct are considered detrimental to the welfare of figure skating by the appropriate authority, I may be subject to penalties imposed by the USFSA pursuant to GR 1.05.

F. I understand that the penalties that may be imposed may include, but are not limited to, loss of future international selections, loss of financial support from the USFSA and Memorial Fund, loss of participation in activities hosted, supported, sponsored, or engaged in by the USFSA.

G. I understand that all disciplinary proceedings will be conducted pursuant to Article XXVI, Section 3, of the USFSA Bylaws and that my rights and remedies are derived therefrom.
